Question: 1

Explanation:

There are 5 options that users can choose from:

- Issue type
- Assignees
- Priorities
- Queries
- None

Question: 2

Razi is creating a new Kanban board with multiple Jira projects. Some of the issues are missing from the board.

Which of the following are true? (Choose two.)

- A. Some statuses are not properly mapped to the correct column.
- B. The user does not have the 'Browse Projects' permission for some projects.
- C. The user does not have the 'View Issues' permission for some projects.
- D. Some issues have 'Issue Level Security' applied.

Answer: B,D

Explanation:

View Issues permission does not exist in Jira.

If users are creating a new board (Kanban or Scrum) with multiple Jira projects, and each project has a unique workflow, all statuses will be mapped to 3 default columns: To Do, In Progress, and Done.

On the Kanban board, the issues will appear on the board as soon as users created the board.

On the Scrum board, the issues will not appear on the board. After creating a new Scrum board, you do not have an active sprint. Only issues in the active sprint will appear on the Scrum board.

Question: 3

Nina's team plans to complete 10 issues in the sprint. However, there are 2 issues still unresolved. As a project administrator, what is the minimum permission Nina needs to complete the current sprint? (Choose four.)

- A. Manage Sprints
- B. Edit Issues
- C. Transition Issues
- D. Move Issues
- E. Schedule Issues
- F. Browse Projects

Answer: A,B,E,F

Explanation:

To complete a sprint, users must be a Jira Administrator. Non-administrator users need Manage Sprints permission to manage the sprint. Since the user is not a Jira administrator, Manage Sprints permission is required.

The user requires Edit Issues and Schedule Issues because there are 2 unresolved issues that need to be moved to the backlog or to the next sprint.

Browse Projects is the required permission to view the issues.

Move Issues permission is for moving issues to another project, which is not required in managing the sprint.

Transition Issues grants users the ability to transition issues' status, which is not required in managing the sprint.

Question: 4

As a scrum master, Nina needs a graphical chart to get the overall story points of each previous sprint to estimate the total story points for the next sprint. Which chart should Nina use?

- A. Control chart
- B. Epic burndown report
- C. Cumulative flow diagram
- D. Velocity chart
- E. Burndown chart

Answer: D

Explanation:

The Velocity Chart displays the average amount of work a scrum team completes during a sprint. Teams

can use velocity to predict how quickly they can work through the backlog because the report tracks the forecasted and completed work over several sprints. The more sprints, the more accurate the forecast. The scrum master can decide the total story points their team can commit for the next sprint by using the previous data in the velocity chart.

Question: 5

Nick is a finance manager for some projects. His Kanban board should only display finance-related issues using Jira components without clicking any buttons on the board. He also needs to ensure the filtered results will not change the result in his Cumulative Flow Diagram report.

Which feature can he use to achieve this?

- A. Board Filter
- B. Quick Filters
- C. Hide completed issues
- D. Board Sub-Filter
- E. Issue Detail View
- F. Swimlanes

Answer: D

Explanation:

Nick should add additional 'component' JQL to the Board Sub-Filter to search for the related components.

JQL search results from the Board Sub-Filter will apply to Jira boards only. (exists in Kanban boards only)

JQL search results from the Board Filter will apply to Jira boards and reports.

Swimlanes is a row on the board that can be used to group issues. There are a few types of Swimlanes; Queries, Stories, Assignees, Epics, Projects, or None. If you choose None, no swimlanes will be displayed. Quick Filters allow users to enable/disable multiple filters with a single click from their Jira board view. If users selected multiple filters, only issues that match selected filters will be displayed. For example, if users selected 'Java Component' and 'High Priority', the result will be issues that have critical issues with Java components only. Quick Filters JQL will not overwrite JQL in your Board Filter. Jira will apply the JQL on top of your existing JQL Board Filter.

Hide Completed Issues allow users to hide completed issues older than 1 week, 2 weeks, or 4 weeks. (exists in Kanban boards only)

Issue Detail View allows users to choose which field appears on the issues.

Question: 6

Dom is working as a project manager for a Jira project called EPAY. The project has been deployed to production and transferred to another company for maintenance.

Which of the following action allows Dom to hide the EPAY issues from the advanced search, but other users can still access the issues through direct links.

Answer: D

Explanation:

Users can archive inactive projects along with their issues, components, attachments, and versions. This won't affect associated schemes, workflows, issue types, or any content that is shared with other projects.

When a project is archived, its issues won't appear in basic or advanced search results. Users can still access these issues through direct links, but you won't be able to edit them.

A hidden project will still be visible to people with admin permissions; regular users won't be able to search, view or modify any of the project's issues.

Users can get rid of projects that they don't need by moving them to trash. The projects along with its issues, components, attachments, and versions will be available in the trash for 60 days, after which they will be permanently deleted. Associated schemes, workflows, issues types, or any content that could be shared with other projects won't be affected. Issues from projects in trash won't appear in issue search results.

To permanently delete a project, users must first move the project to trash. Once they permanently delete a project from the trash, they won't be able to recover it. If they think that they might need the project later, it is recommended to either archive projects or hide projects instead.

Question: 7

Nina is a new hire that will be working on a Jira project. Her manager assigned the below task to her:

- Assign issues to other members
- Nina should not work on any issues
- Move issue's status to other statuses.

What are the minimum permissions that Nina needs to meet these 3 requirements? (Choose two.)

Answer: A,D

Explanation:

Nina only needs Assign Issues and Transition Issues permission. Since she will not be working with any issues, she does not need Assignable User permission. She does not need to have Edit Issues to update the issue's assignee and status.

Assign Issues grants users the ability to assign issues to other people.

Assignable User allows other users to assign issues to this user.

Moves Issues grants users the permission to move issues between projects or between workflows of the same project (if applicable). Note that the user can only move issues to a project that they have 'Create Issues' permission.

Transition Issues grants users the ability to transition issues; from status to another status.

Administer Projects permission allow users to administer a project in Jira, which includes managing versions and components.

Question: 8

Note:

- Company-managed projects are formerly known as classic projects.

Explanation:

Board is just a way to view your issues. Users can create multiple Scrum or Kanban boards on any Scrum or Kanban project.

When creating the Kanban board on a Scrum project, these configurations might need to be updated:

- Issue Type schemes
- Estimation methods
- Work in progress limits
- Custom workflows

For example, the 'Backlog' and 'Selected For Development' statuses from the Scrum board will be grouped under the 'To Do' column in the Kanban Board. There will be a lot of issues in the 'To Do' column.

Components:

Users should use components when they want to auto-assign an issue to a specific user. An issue can have more than one component. Project administrators have the proper access to manage the project component. Since components only belong to a Jira project, users cannot share the component globally with other Jira projects.

Custom fields:

Users should use custom fields if they want the field to be used globally. The custom field has a few field types that can only accept a single value. Jira administrators have global permission to manage the custom field.

Question: 14
