## Question: 2

**Answer: D**

Explanation:

In the case *Chime v. California* (1969), the Supreme Court laid down the rules for arresting officers. The prosecution in the case argued that officers searched the home of Chime to protect themselves. During this time, they found evidence of Chime's crime. The court ruled that the officers only had the right to search the area within Chime's immediate control and not the entire house.

### Question: 4

Which of the following is inappropriate law enforcement that actually causes a crime to be committed?

- A. anomie
- B. entrapment
- C. collateral estoppels
- D. actus reus

**Answer: B**

Explanation:

Entrapment occurs when law enforcement officers induce a person to act unlawfully. Officers may fool people, but they cannot convince a person that an act is not criminal or cause them to commit a crime they would not otherwise commit. Actus reus is literally a guilty act. Collateral estoppels means when a crime has already been judged, it cannot be judged again. Anomie is when ethical or community standards are lost.

### Question: 5

Which policing style described by James Q. Wilson is characterized by the maintenance of order through selective police intervention?

- A. the watchman style
- B. the legalistic style
- C. the service style
- D. the reform style

**Answer: A**

Explanation:

The watchman style is an attempt to create order in the community through targeting undesirable behavior and selective intimidation of people thought to have committed crimes. These

---

tactics can include intimidation through threats and violence against those that disrupt the status quo. The legalistic style refers to a strict adherence to the letter of the law. The service style is the most prevalent today and involves assisting community groups to influence crime statistics. The reform style is not one mentioned by Wilson.
