Answer: A

Explanation:

The article provides information about a scheme to defraud internet users of money. It describes the mechanics of the fraud scheme and explains how the perpetrators intend to make money.

Question: 4

What is a "propensity for larceny?"

- A. A desire for compensation
- B. A proclivity for theft
- C. A talent for robbery
- D. A disinclination for pilferage

Answer: B

Explanation:

A propensity is a tendency to do something. Proclivity is a synonym for this. Larceny is a synonym for theft. Note that pilferage and robbery are also synonyms for theft, but that talent, which is a latent ability, does not mean the same thing as propensity, while disinclination has the opposite meaning.

Question: 5

The hoax described in the paragraph attempts to get the victim to send money to the perpetrator for what reason?

Answer: B

Explanation:

According to the paragraph, the perpetrators cite many reasons for the need to send them money, among them payment of taxes, bribes to government officials, and legal fees.

Question: 6

- B. It is a good reason not to open email attachments.

Answer: D

Explanation:

Question: 7

This document is what type of document?

Answer: B

Explanation:

As set out in section 1.0, Purpose and Scope, the document describes a procedure for identifying hazards associated with one or more jobs (in this case Tank Operations) or encountered by visitors and for instituting controls to mitigate (or minimize) the dangers that they present.

Question: 8

According to the procedure, if a worker is exposed to a hazardous chemical, which of the following is the last thing that should be tried to prevent injury or illness?

- A. Use a different chemical.
- B. Install fans to keep fumes away from the worker.
- C. Measure the amount of exposure of each affected worker.
- D. Give the worker protective clothing.

Answer: D

Explanation:

The methods to be used to mitigate hazards are given in section 4.1 of the text, which indicates that they are specified in descending order of use. Protective clothing is an example of the last method listed, personal protective equipment, so this is the last strategy to be tried to protect the workers from the hazardous chemical.

Question: 9

Welders must always use goggles and are taught to use them as part of their basic training. According to the text, which of the following is also true regarding the work instructions?

- A. The use of goggles during specific welding operations should be prominently displayed at the beginning of the work instruction
- B. The use of goggles during specific welding operations should be displayed as a caution prior to the welding step described in the work instruction
- C. The use of goggles during specific welding operations should be described in detail in the work instruction
- D. The use of goggles during specific welding operations should not be discussed in the work instruction

Answer: D

Explanation:

Section 4.2 indicates that safety procedures ("controls") that fall within the scope of normal training for workers do not need to be discussed in the work instructions for operations that are performed frequently.

Question: 10

- B. Laborers at the site
- C. Visitors to the site
- D. Workers making deliveries to the site

Answer: A

Explanation:

The document is intended as a guide for those writing work instructions for jobs to be performed at the site. These work instructions are prepared by management. Workers and laborers would read those documents as part of their training.
