### Topic: 1

### Written Comprehension

#### Question: 1

Beginning at 10:57 on the night of July 23rd, the 911 service received several phone calls reporting a large fight at a night club downtown. Four squad cars with eight officers responded immediately and found about a dozen adult males engaged in a melee. Within five minutes of arriving on the scene, they had the situation under control, and they began interviewing the combatants and witnesses. One of the combatants, Jose Mendez, told Officer Ronald Jones that the fight had begun when another man had assaulted his (Mendez's) date by tossing his drink in her face, and he had responded by punching the man. Officer Shantel Williams interviewed the man Mendez accused of starting the fight, Roland Hemphill, who denied tossing his drink on anyone, and said that he had tripped and accidentally spilled his drink on a woman, whose date then punched him. At this point, according to Hemphill and other witnesses, friends of both parties jumped in to defend their friends. Officer Mark Jones interviewed Tyreese Smith, the bartender, who said that he hadn't seen how it started as he had his back turned toward the crowd at the moment the fight erupted. Several other witnesses, who spoke to Officers Mike Smith and Wendell Brown, backed up Hemphill's account that the drink was spilled accidentally. There were no witnesses who claimed he tossed the drink deliberately. After interviewing nearly everyone on the scene, officers arrested Jose Mendez for battery.

Which officer interviewed the victim of Mendez's battery?

Explanation:

The passage states that Jose Mendez punched a man who spilled a drink, and that the name of the man who spilled the drink was Roland Hemphill. It goes on to say that Officer Shantel Williams interviewed Hemphill. Officer Ronald Jones interviewed Mendez. Officer Mike Smith interviewed several witnesses who confirmed Hemphill's account. Officer Mark Jones interviewed the bartender, Tyreese Smith.

### Question: 2

At approximately 2:44 p.m., Officer Rafael Sandoz located a stolen motor vehicle in a driveway of a residence in the 2000 block of Fair Havens Drive. The vehicle was unoccupied and it was quickly determined that it had recently been stolen from Orlando. Officer Sandoz called for backup. Shortly thereafter, Officers Macy Blevins and Officer Nick Glenn knocked on the door of the residence, and after identifying themselves and entering the house, questioned several individuals inside with regards to the stolen car. One of the individuals was in possession of suspected illegal narcotics and provided officers with false personal identifying information. She was eventually identified as Asia Campos and she was arrested on an outstanding warrant. While at the same location the three officers discovered another motor vehicle that had been reported stolen from Pensacola parked in the garage. They also discovered a motorcycle reported stolen from Pensacola behind the house. There were also illegal narcotics inside of the residence. The investigation led to the arrest of Ronald Holderman for the Orlando stolen motorcycle.

How many people were arrested?

- A. One
- B. Two
- C. Three
- D. Four

**Answer: B**

Explanation:

Asia Campos was arrested on an outstanding warrant, and Ronald Holderman was arrested for the theft of the motorcycle from Orlando.

### Question: 3

Just prior to Lights Out at a medium-security state prison, corrections staff staged an unannounced search for contraband after receiving several reports that at least two inmates possessed homemade knives and were planning to use them to "settle some scores." Although a thorough search turned up no knives, several contraband items were discovered and seized. Correctional Officer Steve Wilson found a marijuana cigarette in Inmate Reggie Wilson's pillow, and a cup of homemade wine in Inmate Robert Doolittle's cell. Correctional Officer Bob Jackson found a mobile phone in the cell of Inmates Mustafa Johnson and Dewayne Smith; both men denied that the phone was theirs. In a cell shared by Inmates Ryan McDonald and Brent Travers, Correctional Officer Emilio Padilla discovered three syringes and a metal spoon: both inmates claimed that the drug paraphernalia wasn't theirs and they were being "set up."

Altogether, how many contraband items were discovered?

Seven items of contraband were found in the sweep — (1) a marijuana cigarette in Inmate Reggie Wilson's pillow, (2) a cup of homemade wine in Inmate Robert Doolittle's cell, (3) a mobile phone in the cell of Inmates Mustafa Johnson and Dewayne Smith, and (4, 5, 6 and 7) three syringes and a metal spoon in a cell shared by Inmates Ryan McDonald and Brent Travers.

### Question: 4

On June 29 at approximately 11:30 a.m., two officers with from the police departments Southern Division were dispatched to a hotel in the 4500 block of Nevada Ave. to follow up on a missing person report about an adult, later identified as Eleanor Snowden, a 68-year-old female. The investigation revealed that Ms. Snowden registered as a guest of the hotel on June 20 but she has not been seen since June 22. Ms. Snowden has a condition that qualifies her as an at-risk member of the community and as such, our department is asking for assistance in locating her. Ms. Snowden is described as a white female, 5'08", 145 pounds, gray hair with blue eyes, and who was last seen wearing a gray hooded sweatshirt and blue pajama pants. A photograph of Ms. Snowden is available if requested. How long has Ms. Snowden been missing?

- A. Two days
- B. Five days
- C. Seven days
- D. Ten days

**Answer: C**

Explanation:

Ms. Snowden checked into the hotel on June 20. She was seen on June 22, but hasn't been seen since. The date of the officer's visit is June 29, which means seven days have passed since June 22, the last time anyone saw Ms. Snowden.

**Answer: B**

Explanation:  
One person in the front row is wearing a dress.

**Answer: B**

Explanation:

One person is wearing glasses—the woman the dog is standing in front of.

### Question: 7

What is the woman whose luggage the dog is sniffing doing?

- D. Reading a book

**Answer: D**

Explanation:

The woman whose luggage the dog is sniffing is reading a book

### Question: 9

Which officer is taller?

**Answer: D**

Explanation:

The officer on the right is taller.
